BY-LAW NO. 95-06

A BY-LAW OF THE VILLAGE OF GIROUXVILLE, IN THE PROVINCE OF ALBERTA,  
TO ESTABLISH DEVELOPMENT AUTHORITY FOR THE VILLAGE OF GIROUXVILLE  
UNDER THE PROVINCE OF ALBERTA MUNICIPAL GOVERNMENT ACT.

WHEREAS, The Municipal Government Act requires a council to provide for a Development Authority to exercise development powers and duties on behalf of the municipality, and

WHEREAS, The Village of Girouxville has a Development Officer and a Joint Municipal Planning Commission to exercise Development Authority powers and duties.

NOW THEREFORE, The Council of the Village of Girouxville, in the Province of Alberta, duly assembled, hereby enacts as follows:

1.0 Purpose And Title:

1. The purpose of this By-Law is to establish the Development Authority for the Village of Girouxville.
2. This By-Law may be cited as the "Development Authority Bylaw".

2.0 Definitions:

The following words and terms are defined as follows:

1. "Council means the Council of the Village of Girouxville.
2. "Development Officer" means the person appointed to the position of Development Officer by Council and pursuant to the Village of Girouxville Land Use Bylaw No. 309.
3. "Joint Municipal Planning Commission" means the Joint Municipal Planning Commission established pursuant to the Smoky River Joint General Municipal Plan Bylaw No. 293.

3.0 Establishment Of Development Authority:

1. That the Development Authority for the Village of Girouxville is the person appointed by resolution of Council as Development Officer pursuant to the Village of Girouxville Land Use Bylaw No. 309.
2. Under the provisions of the Smoky River Joint General Municipal Plan Area, the Joint Municipal Planning Commission, as established by bylaw, shall be the Development Authority for the Village of Girouxville.


4.0 Powers and Duties:


The Development Authority shall be carried out in accordance to powers and duties set out in the Municipal Government Act, any regulations established under the Municipal Government Act, the Smoky River Joint General Municipal Plan and the Village of Girouxville Land Use Bylaw No. 309, as amended from time-to-time.

5.0 Effective Date:


This Bylaw shall come into effect on the date of the third and final reading of this Bylaw.




