

**BYLAW NO. 22-02
OF THE VILLAGE OF GIROUXVILLE
IN THE PROVINCE OF ALBERTA**

**A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE
LEVIED TO ASSESSABLE PROPERTY WITHIN THE VILLAGE
OF GIROUXVILLE FOR THE 2022 TAXATION YEAR.**

WHEREAS, the Village of Girouxville of Alberta has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the Council meeting held on May 11, 2022; and

WHEREAS, the estimated municipal expenditures and transfers set out in the budget for the Village of Girouxville of Alberta for 2022 total \$922,625; and

WHEREAS, the estimated revenues and transfers from all sources other than taxation is estimated \$635,525, and the balance of \$287,100. is to be raised by general municipal taxation; and

WHEREAS, the estimated requisitions are:

WHEREAS, Council of the Village of Girouxville is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

WHEREAS, Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M-26; Revised Statutes of Alberta, 2000; and

WHEREAS, the assessed value of all property in the Village Girouxville as shown on the assessment roll is:

NOW THEREFORE, under the authority of the Municipal Government Act, the Council of the Village of Girouxville of Alberta, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Village of Girouxville of Alberta.

2. That the minimum amount payable per parcel as property tax for general municipal purposes shall be \$500.00.
3. This bylaw comes into force at the beginning of the day that it is passed unless otherwise provided for in the *MGA* or another enactment or in the bylaw. This bylaw is passed when it receives third reading and it is signed in accordance with S.213 of the *MGA*.


