

**BYLAW NO. 25-02  
VILLAGE OF GIROUXVILLE**

**A BYLAW OF THE VILLAGE OF GIROUXVILLE, IN THE  
PROVINCE OF ALBERTA, TO ESTABLISH ALTERNATE  
METHODS FOR ADVERTISING STATUTORY AND NON-  
STATUTORY NOTICES IN THE VILLAGE OF GIROUXVILLE**

**WHEREAS**, pursuant to section 606 of the *Municipal Government Act*, a council must give notice of certain bylaws, resolutions, meetings, public hearings or other things by advertising in a newspaper or other publication circulating in the area, mailing or delivering a notice to every residence in the affected area or by another method provided for in a bylaw under section 606.1;

**AND WHEREAS**, pursuant to section 606.1(1) of the *Municipal Government of Act*, a council may by bylaw, provide for one or more methods, which may include electronic means, for advertising proposed bylaws, resolutions, meetings, public hearings and other things referred to in section 606;

**AND WHEREAS** the Council of the Village of Girouxville is satisfied that the advertising method of this Bylaw is likely to bring matters advertised by that method to the attention of substantially all residents in the area to which the bylaw, resolution or other thing relates or in which the meeting or hearing is to be held;

**NOW THEREFORE** the Council of the Village of Girouxville, in the Province of Alberta, duly assembled, enacts as follows:

**PURPOSE AND TITLE**

1. This Bylaw may be referred to as the "Public Notification Bylaw".

**ADVERTISING METHOD**

2. Any notice required to be advertised under section 606 of the *Municipal Government Act* of a bylaw, resolution, meeting, public hearing or other thing may either be given, in accordance with the timelines prescribed in section 606,
  - a) in the local newspaper
  - or
  - b) electronically by posting the notice prominently on the Village of Girouxville's official website and may also be posted on social media sites;
  - or
  - c) by posting the notice prominently on the bulletin board provided for that purpose at the entrance of the Village of Girouxville's administration building;
  - or
  - d) by placing flyers or posting the notice prominently on the bulletin board or displays at local establishments frequented by Village of Girouxville residents/business owners.

**SEVERABILITY**

1. If any portion of this Bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion shall be severed.

**EFFECTIVE DATE**

**This Bylaw shall come into force and effect when it receives third and final readings.**
